THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1316/2013 of the European Parliament and of the Council of 11 December 2013 establishing the Connecting Europe Facility, amending Regulation (EU) No 913/2010 and repealing Regulations (EC) No 680/2007 and (EC) No $67/2010^{1}$ and in particular Article 18(1) thereof,

Whereas:

- Commission Implementing Decision C(2018)6599 of 12 October 2018 established an Annual Work Programme for financial assistance in the field of Connecting Europe Facility (CEF) – Transport sector for 2019 ('Annual Work Programme').
- (2) Pursuant to Implementing Decision C(2018) 6599 the Commission launched the 2019 CEF Transport call for proposals on 5 December 2018. The call aimed at supporting projects of common interest regarding two priorities: projects on the TEN-T comprehensive network and reduction of rail freight noise.
- (3) Following the call for proposals, and based on the eligibility, selection and award criteria laid down in the Annual Work Programme and in the call text, the Commission selected 39 projects of common interest, out of which 31 for the priority 'Projects on the TEN-T comprehensive network' and 8 for the priority 'Reduction of rail freight noise'. The total recommended funding is €117,174,810, out of which € 97,689,209 for the first priority and €19,485,600 for the second one. The Commission considers that all the selected projects meet the required criteria.
- (4) The Commission, acting in accordance with the procedure referred to in Article 25(2) of Regulation (EU) No 1316/2013 of the European Parliament and of the Council should decide on the amount of financial assistance to be granted to the projects or parts of projects selected.
- (5) The list of projects of common interest selected by this Decision is in accordance with the opinion of the Committee referred to in Article 25(1) of Regulation (EU) No 1316/2013 of the European Parliament and of the Council.

Sole Article

The lists of projects of common interest selected and not selected for receiving EU financial assistance under the Connecting Europe Facility (CEF) – Transport sector based on the Annual Work Programme 2019 in accordance with Implementing Decision C(2018)6599, as laid down respectively in Part I and II of the Annex, are approved.

The list of selected projects includes the estimated total eligible costs of the actions, the percentage of the financial assistance out of the estimated total eligible costs and the respective maximum amounts of the financial assistance.
