THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1316/2013 of the European Parliament and of the Council of 11 December 2013 establishing the Connecting Europe Facility¹ (hereafter "CEF Regulation"), and in particular Article 18 thereof,

Whereas:

- (1) Commission Implementing Decision C(2016) 1778 of 31 March 2016 established the annual work programme for 2016 for a multi-sectoral call for proposals under the Connecting Europe Facility.
- When establishing the work programme the Commission applied the criteria laid down in Article 7 of the CEF Regulation and the objectives and priorities defined in Regulation (EU) No 1315/2013 of the European Parliament and of the Council of 11 December 2013² and in Regulation (EU) No 347/2013 of the European Parliament and of the Council of 17 April 2013³.
- (3) Following the call for proposals launched on 28 September 2016 and based on the eligibility, selection and award criteria laid down in sections 5, 6 and 7 of Annex I of Commission Implementing Decision C(2016) 1778, the Commission selected projects of common interest for receiving EU financial assistance under the Connecting Europe Facility. All selected projects meet the required criteria.
- (4) The Commission, acting in accordance with the procedure referred to in Article 25(2) of Regulation (EC) No 1316/2013, should decide on the amount of financial assistance to be granted to the projects or parts of projects selected.
- (5) The list of projects of common interest selected by this Decision is in accordance with the opinion of the Committee referred to in Article 25(1) of Regulation (EC) No 1316/2013.

Article 1
