### THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2021/1153 of the European Parliament and of the Council of 7 July 2021 establishing the Connecting Europe Facility and repealing Regulations (EU) No 1316/2013 and (EU) No 283/2014<sup>1</sup>, and in particular Article 21(1) thereof,

### Whereas:

- (1) Commission Implementing Decision C(2021)5763<sup>2</sup> established a multi-annual work programme for granting Union financial assistance to projects of common interest in the field of trans-European transport network infrastructure under the Connecting Europe Facility (CEF) for the period 2021-2027.
- (2) Based on the multi-annual work programme, a call for proposals for grants under the CEF Transport Military Mobility budget envelope was published on 12 May 2022.
- (3) By the deadline of 29 September 2022, 63 project proposals were submitted, of which 53 complied with the formal admissibility and eligibility requirements and were assessed against the evaluation criteria in accordance with Article 200 of Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council<sup>3</sup>.
- (4) Following the evaluation, 35 Military Mobility projects were selected to receive financial assistance under the CEF for a total amount of EUR 616.049.555,71.
- (5) The list of selected projects established by this Decision is in accordance with the opinion of the Connecting Europe Facility Coordination Committee,

## HAS DECIDED AS FOLLOWS:

#### Sole Article

The Military Mobility projects listed in the Annex are selected for grants under the Connecting Europe Facility for the period 2021-2027.

The maximum amount of financial assistance granted to the selected projects shall be as set out in the Annex.
