A roundtable discussion took place, which allowed for the exchange of information about ongoing work and recent decision-making practice, main issues of pending/recent procedures and problems of transposing Union railway law.

4. Update by DG Competition on recent cases

Firstly, it was reported that the Commission took a decision to fine Lithuanian Railways €28 million for hindering competition on the rail freight market (please see here the press release http://europa.eu/rapid/press-release_IP-17-3622_en.htm and here the decision itself http://ec.europa.eu/competition/elojade/isef/case_details.cfm?proc_code=1_39813).

Secondly, DG Competition referred to the opening of an in-depth investigation into support granted to the Romanian rail freight operator CFR Marfa (please see the press release here: http://europa.eu/rapid/press-release_IP-17-5345_en.htm).

Thirdly, DG Competition referred to the opening of another in-depth investigation into restructuring aid for Polish Regional Railways.

It was reported that there were concerns that the company had already received State aid in the past and it was highlighted that EU rules allow a company to receive restructuring aid only once over a 10-year period (please see the press release here: http://europa.eu/rapid/press-release_IP-18-394_en.htm)

ii. Service facilities information template - Follow-up to the February workshop

RNE had been working on the development of a service facilities common template. A rail sector meeting took place on 22 February 2018 at CER's premises to consult all interested stakeholders. Concerns were raised regarding the user-friendliness of the template. RNE committed to make the necessary amendments.

Regarding the GIS Portal, mapping Last-mile infrastructure (LMI) in Europe, it was developed in 2016 to remedy the lack of access to information on LMI. The first pilot version (www.railfreightlocations.eu) was developed during the first contract. It is not yet complete neither in terms of geographical coverage nor in number and type of facilities. A second contract will be launched with the aim of completing the portal and presenting the production version. At the end of that second contract the objective is to hand it over for management by the sector under conditions that will be discussed in the course of the contract.

The Portal's objective is not only to constitute a market tool offering an easy and user-friendly access to information about rail freight facilities but also to constitute the tool of choice for Service Facility operators to comply with their obligation to publish access information under Implementing Regulation 2017/2177.

Lastly, the portal will be further developed so as to accommodate passenger rail facilities.
