THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Regulation (EC) N° 680/2007 of the European Parliament and of the Council of 20 June 2007 laying down general rules for the granting of Community financial aid in the field of trans-European transport and energy networks¹, and in particular Article 8 thereof,

Whereas:

- (1) In accordance with the conclusions of the Presidency of the European Council Meeting in Brussels on 11 and 12 December 2008 and the Communication from the Commission to the European Council of 26 November 2008 regarding the European Economic Recovery Plan (EERP)², the Commission shall launch a €500 million call for proposals for trans-European transport (TEN-T) projects where this money would lead to construction beginning before the end of 2009.
- (2) Commission Decision C(2009) 2183 of 30 March 2009 establishes the 2009 work programme as foreseen in the European Economic Recovery Plan (EERP) for grants in the field of the trans-European transport network (TEN-T) for the year 2009.
- (3) The Commission has applied the criteria laid down in Article 5 of Regulation (EC) N°680/2007 and the objectives and priorities defined in the framework of Decision No 1692/96/EC of the European Parliament and of the Council of 23 July 1996 on Community guidelines for the development of the trans-European transport network³ when establishing the 2009 work programme as foreseen in the European Economic Recovery Plan (EERP).
- (4) Based on the 2009 work programme as foreseen in the European Economic Recovery Plan (EERP) the Commission has launched on 31 March 2009 a call for proposals for projects of common interest in the field of the Trans-European Networks for Transport (TEN-T)
- (5) Following the call for proposals based on the 2009 work programme as foreseen in the European Economic Recovery Plan (EERP), the Commission, acting in accordance with the procedure referred to in Article 15(2) of Regulation (EC) No 680/2007, should decide on the amount of financial aid to be granted to the projects or parts of projects selected.
