**establishing the list of proposals selected for receiving EU financial assistance under the Connecting Europe Facility (CEF) – Transport sector following the calls for proposals launched on 16 October 2019, based on the Multi-Annual Work Programme pursuant to Commission Implementing Decision C(2014)1921**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1316/2013 of the European Parliament and of the Council of 11 December 2013 establishing the Connecting Europe Facility, amending Regulation (EU) No 913/2010 and repealing Regulations (EC) No 680/2007 and (EC) No 67/2010<sup>1</sup>, and in particular Article 18(1) thereof,

Whereas:

- (1) Commission Implementing Decision C(2014)1921 of 26 March 2014 established a Multi-Annual Work Programme for financial assistance in the field of Connecting Europe Facility (CEF) – Transport sector for the period 2014-2020 ('Multi-Annual Work Programme').
- (2) Commission Implementing Decision C(2019)7303 of 16 October 2019 amended Implementing Decision C(2014) 1921 in order to provide for calls for proposals for projects of common interest in the transport sector, under the General and Cohesion envelopes of CEF Transport, for the following funding objectives: removing bottlenecks and bridging missing links; ensuring sustainable and efficient transport in the long run; and optimising the integration and interconnection of transport modes and enhancing interoperability, safety and security of transport.
- (3) Pursuant to Implementing Decision C(2014)1921 as amended by Implementing Decision C(2019)7303 the Commission launched such calls for proposals on 16 October 2019.
- (4) Following the calls for proposals, and based on the eligibility, selection and award criteria laid down in the Multi-Annual Work Programme and in the call texts, the Commission selected 130 projects of common interest, out of which 94 under the General envelope and 36 under the Cohesion envelope. The total recommended funding is EUR 2 111 481 603, out of which EUR 967 381 776 for the General envelope and EUR 1 144 099 827 for the Cohesion envelope. The reasons for the selection or rejection of proposals are set out in the call evaluation report which includes individual evaluation forms.
- (5) The Commission, acting in accordance with the procedure referred to in Article 25(2) of Regulation (EU) No 1316/2013 should decide on the amount of financial assistance to be granted to the projects or parts of projects selected.

The lists of projects of common interest selected and not selected for receiving EU financial assistance under the Connecting Europe Facility (CEF) – Transport sector based on the Multi-Annual Work Programme 2014-2020 in accordance with Implementing Decision C(2014)1921, including for the selected projects the estimated total eligible costs of the actions, the percentage of the financial contribution out of the estimated total eligible costs and the respective maximum amounts of the financial contribution, as laid down respectively in Part I and Part II of the Annex, are approved.
