THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2021/1153 of the European Parliament and of the Council of 7 July 2021 establishing the Connecting Europe Facility and repealing Regulations (EU) No 1316/2013 and (EU) No 283/2014¹, and in particular Article 21(1) thereof,

Whereas:

- (1) Commission Implementing Decision C(2021)5763² established a multiannual work programme for granting Union financial aid to projects of common interest in the field of trans-European transport network infrastructure under the Connecting Europe Facility (CEF) for the period 2021-2027.
- (2) Based on the multi-annual work programme, calls for proposals for grants under the CEF Transport General, Cohesion and Military Mobility budget envelopes were published on 16 September 2021.
- (3) By the deadline of 19 January 2022, 26 project proposals were submitted under the Military Mobility envelope. All 26 proposals complied with the formal admissibility and eligibility requirements and were assessed against the evaluation criteria in accordance with Article 200 of Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council³.
- (4) Following the evaluation, 22 Military Mobility projects were selected to receive financial assistance under the Connecting Europe Facility.
- (5) The list of selected Military Mobility projects established by this Decision is in accordance with the opinion of the Connecting Europe Facility Coordination Committee,

HAS DECIDED AS FOLLOWS:

Sole Article

The Military Mobility projects listed in the Annex are selected for grants under the Connecting Europe Facility for the period 2021-2027.
