THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EC) N° 680/2007 of the European Parliament and of the Council of 20 June 2007 laying down general rules for the granting of Community financial aid in the field of trans-European transport and energy networks¹, and in particular Article 9(1) thereof,

Whereas:

(1) Commission Decision C(2009)2179 of 30 March 2009 establishes the annual work programme for grants in the field of the trans-European transport network (TEN-T) for the year 2009.

(2) The Commission has applied the criteria laid down in Article 5 of Regulation (EC) N°680/2007 and the objectives and priorities defined in the framework of Decision No 1692/96/EC of the European Parliament and of the Council of 23 July 1996 on Community guidelines for the development of the trans-European transport network² when establishing the annual work programme.

(3) Based on the annual work programme the Commission has launched on 31 March 2009 a call for proposals for projects of common interest in the field of the Trans-European Networks for Transport (TEN-T)

(4) Following the call for proposals based on the annual work programme, the Commission, acting in accordance with the procedure referred to in Article 15(2) of Regulation (EC) No 680/2007, should decide on the amount of financial aid to be granted to the projects or parts of projects selected.

(5) The selection provided for in this Decision is in accordance with the opinion of the Committee set up under Article 15(1) of Regulation (EC) No 680/2007,

HAS ADOPTED THIS DECISION:

Article 1

The list of projects of common interest in the area of the trans-European transport network selected for receiving EU financial aid, the estimated total eligible cost of the action, the equivalent
