## 1) Presentation by UIRR (member of the portal consortium) on the progress of the EU Rail facility portal

The discussion raised questions on quality management, on whether the publication obligation covers both static and dynamic information, on the period of validity of the information submitted, on the interaction of the portal with other existing databases, on the users' needs, on the economic sustainability of the project and the role of regulators. Regulators were asked to raise awareness on the portal project and to provide the portal consortium with their input on what needs to be improved.

# 2) Presentation by IRG-Rail of its position paper on the exemptions under Article 2 of Implementing Regulation (EU) 20117/2177

IRG-Rail presented its newly issued paper which sets out common decision making principles that should be applied by the national regulatory bodies when assessing requests for an exemption under article 2 (2) of the Implementing Regulation. Various regulators reported that they intend to translate the IRG-Rail document in their respective national language. Incorporating the principles embodied in IRG-Rail's paper in an implementing act will be considered at a later stage.
